

## **WARRANTY REFERRED TO MAINTENANCE CONTRACT**

It is understood and agreed that in addition to the terms, exclusions, clauses and conditions contained in this Section or in endorsements, the Company shall only indemnify the Insured for damage or loss if the insured has entered into a maintenance contract with the manufacturer or supplier of the property or properties specified in the schedule, attached hereto, according to which the manufacturer or supplier binds himself to provide the necessary service to warrant regular maintenance and operation tests of the property covered.

This clause shall only apply when in the Specification of the Policy it is specified that the equipment requires a maintenance contract.
