

BRANDS AND LABELS CLAUSE

In the event of damages to properties bearing a factory's brand, whose sale in any way includes a warranty from the Insured, the salvage value of such damaged property shall be determined upon removing all registered or factory brands that may be considered as an indicative that the manufacturer's or Insured's warranty or factory brand covers such property. The Company agrees with the Insured, in respect to merchandises or containers from which it is not practical to remove all evidence of the connection that the Insured have with them in order to make use of the remainders, only with the salvage brand, or the destruction of such merchandises or containers in the presence of the Insured's representative.
